WE CURRENTLY HAVE NEARLY 600 PEOPLE IN OUR CLUB, BUT CAN POTENTIALLY INCLUDE MANY MORE. THE CLUB PUBLISHES A PERIODIC NEWSLETTER ON NOJI.COM/UVARCSTACK AND HOSTS HAM RADIO COURSES, EXAM SESSIONS, AND SPECIAL EVENTS, SUCH AS FIELD DAY AND HAMFESTS.
